



Square-A-Bration Giveaway Official Rules

1. Eligibility: The Imo's Pizza® Square-A-Bration Giveaway is open to legal residents of the United States of America who enter the Sweepstakes in accordance with the rules as described in Section 5 below or sign up at <https://bit.ly/squareabration>. Entrants must be 18 years of age or older as of their date of entry in this promotion in order to qualify.
